Our policy platform is grounded on the premise that meaningful partnerships lead to collaborative strategies and action plans to successfully change systems. In most circumstances, advocacy is successful when organizations and individuals join forces to advocate and lobby for systems change. Agencywide alignment on policy priorities is crucial to ensuring a unified voice on decisions before city/county, state and national policymakers.

Behavioral Health

We innovate service delivery models to advance integrated health care for children, youth, adults and communities, and advance systems change by leading in the delivery of integrated health care and building the crisis continuum of care. We advocate for maximizing federal, state, managed care and private insurance reimbursement.

School-Based Mental Health Services

We initiate meaningful and trusted partnerships with schools for the provision of comprehensive, multitiered behavioral health care and advocate for robust partnerships to best meet the needs of all children, youth, and adult caregivers.

Child Welfare Services

We advocate for evidence-based and community-based practices that guide child and youth safety, permanency, and well-being. We partner with other advocates to support strength-based programs that meet the unique needs of each child. We advance the development of innovative family-based care options, particularly for children and youth formerly placed in congregate care or out-of- state facilities.

Justice, Equity, Diversity & Inclusion

We prioritize efforts to eliminate health disparities and address racial, gender and disability inequities. We engage in internal organizational and broader systems change that transform practices and policies. We identify strategies and partner with a diverse group of stakeholders to further inclusive practices, racial justice, equity, and community change.

Early Education

We advance the expansion of and access to highquality, subsidized early education for vulnerable children to increase educational success and life-long opportunities.
